Sir/Madam,

I have the honour to invite your Administration to participate in the ICAO Asia/Pacific Performance-Based Navigation (PBN) Development Workshop 2012 and The Tenth Meeting of the Performance Based Navigation Task Force (PBN/TF/10), hosted by the Civil Aviation Authority of the Fiji Islands in Nadi, Fiji from 10 to 13 December 2012.

The PBN Workshop is an ICAO Special Implementation Project (SIP), approved to assist small Pacific Island States to develop a PBN Plan.

The workshop will be held from Monday, 10 December to Tuesday afternoon, 11 December 2012, and will be followed by the PBN/TF/10 from the same afternoon of 11 December to Thursday, 13 December 2012.

In addition, please note that a Global Navigation Satellite System Landing System (GLS) Seminar will be held in Sydney, Australia from Thursday, 6 until Friday, 7 December 2012, to enable participants travelling to the PBN/TF/10 and Workshop to travel via Sydney if desired. This event will be conducted by Airservices Australia in cooperation with the Civil Aviation Safety Authority, with venue details to be advised. The GLS Seminar is in accordance with the following APANPIRG Conclusion:

Conclusion 23/26 - Asia/Pacific GLS Seminar

That, ICAO plans an Asia/Pacific GNSS Landing System (GLS) Seminar to provide information on emerging GLS technology, airport and airline GLS planning, and the development of applicable standards.

The PBN/TF/10 meeting will continue to promote PBN knowledge sharing and facilitate PBN implementation in the Asia/Pacific Region as well as to identify the PBN implementation gaps, particularly in State PBN Implementation Plans.

2. Visa and Entry Requirements for Fiji

Visitors from most countries do not require a visa but some do. Please check the Fiji Immigration Department Visa and Entry Requirements (www.immigration.gov.fj/) to determine your Visa or Entry Permit requirements, and the length of stay permitted in Fiji. You can also obtain further advice from your closest Fijian Diplomatic or Consular Mission.

3. Currency and Credit Cards

The Fijian Dollar is pegged to the US\$ at FJ\$1.764 to US\$1. Fiji has a comprehensive ATM network and most establishments accept Credit Cards.

4. Language

The official languages are English and Fijian (widely spoken in the service industry).

5. Weather

Fiji has a warm tropical climate perfect for beachside holidays. Maximum temperatures rarely move out of the 31°C (88°F) to 26°C (79°F) range all year round. Southeast trade winds from March to November bring dry weather and the rainy season runs from December to April. On average there are 15 cyclones per decade, and two to four actually cause severe damage. They occur from November to April and with greatest frequency in January and February. There is more risk in the outlying northwest island groups.

Fiji does have a wet season, which is characterised by heavy, brief local showers and contributes most of the country's annual rainfall. The wet season is normally from November to April and results from the southerly movements of the South Pacific Convergence Zone. Typically the smaller islands in Fiji receive less rainfall than the main Island with various amounts according to their location and size. Cyclones do occur in Fiji and are normally confined to wet season.

6. Electricity

Electricity is 220-240 volts, 50Hz. Most sockets accept primary socket type (Aust style AS-3112).

7. Water

Water from public mains meets international health standards. Electric kettles are available in most hotels. Bottled water is readily available.

8. Telephone

Public telephones accept credit cards or phone cards. Phone cards can be purchased at convenience stores

9. Time Zone

Fiji is twelve hours ahead of Greenwich Mean Time (UTC+12hrs + 1hr Daylight Savings to end of March).
