— Introduction – WP/02A

- **ANC reviewed APIRG/26 & RASG-AFI/9 Report**
 - in March 2024
- **Review was based on review by ANC WG/SRP**
 - in February 2024
 - with participation of Chairpersons of APIRG & RASG-AFI
 - and ESAF & WACAF Regional Offices and HQ
- **ANC agreed on consolidated annual report on PIRGs & RASGs**
 - in October 2024
 - covering meetings from 1 April 2023 to 31 May 2024
 - included overview of APIRG/26 & RASG-AFI/9 outcomes

— Definition of AFI Region

- ANC noted deliberation on aligning definition of AFI Region
 - with actual geographical area of APIRG & RASG-AFI
- Council Decision (C-DEC 230/2) on this subject
 - requesting SEC to initiate formal amendment process
- SEC (HQ + ESAF & WACAF Offices) is working on solution

— Space Launch & Re-entry Ops

- Similar occurrences in other regions being monitored
 - may result in global concern
 - given anticipated expansion of high airspace ops
 - topic addressed in AN-Conf/14
- Expert groups to be tasked on topic
 - time needed to progress work
 - may lead to collection of regional feedback
- SEC looking to coordinate with other Regions
 - which have guidance material
 - may be used as basis for guidance at global level

— Significant Safety Concerns

- SSCs concerning approval of instrument flight procedures
- State is obligated to resolve SSC
 - to prevent any immediate safety risk to int'l civil ops
- No exemption should be granted
 - whole process of SSC would be jeopardized
- ANC emphasized State's responsibility to resolve SSC
 - via USOAP mechanisms
 - Regional Offices to support States in their effort to improve safety

— Accident Investigations

- Deficiencies in AIG considered Global Challenge
 - also discussed at AN-Conf/14
- Issue is two-fold
 - independence of AIA
 - completion of final reports
- ANC noted actions to address these
 - initiating an implementation support project
 - promote use of RAIOS & ICMs

— SSP Implementation

- Low level of SSP implementation remains Global Challenge
- SEC to identify ways to address difficulties experienced
 - to support implementation
- ANC to identify ways to address difficulties experienced
 - and report to Council
- New SSP-related PQs available on OLF
 - for transition from SSPIA into USOAP
- 5 SI & SPM Workshops delivered in 2023-2024 across ICAO regions

— ASBUs

- Notification mechanism to inform States on changes applied to ASBUs
 - in GANP Portal
- Changes to ASBU content only made during Assembly cycles
 - every three years
 - no changes being published in between
 - only following Assembly endorsement
- GANP-SG deliberating on solution to reflect differences effectively
 - between editions of GANP
 - to inform of changes made
