1.1 The meeting may recall that the twenty-sixth Meeting of the AFI Planning and Implementation Group (APIRG/26) and Ninth Meeting of the AFI Regional Aviation Safety Group (RASG - AFI/9) were held from 6 to 10 November 2023 in Cotonou, Benin. Two joint sessions convened on 6 and 10 November 2023 adopted 3 Conclusions and 2 Decisions.

1.2 The Extraordinary Meeting of the Africa – Indian Ocean Planning and Implementation Regional Group (APIRG) and the Regional Aviation Safety Group for Africa – Indian Ocean (RASG-AFI) was held on 19 July 2024 in Libreville, Gabon. The meeting adopted 2 Decisions.
