#### 1. INTRODUCTION

1.1 The RASG-AFI is mandated to develop and implement a work programme that supports the regional performance framework for the management of safety on the basis of the Global Aviation Safety Plan (GASP) and the Global Aviation Safety Roadmap (GASR).

#### 2. DISCUSSIONS

- 2.1 The RASG AFI Terms of reference (ToRs) states that the Chairperson shall decide on the date and duration of meetings of the Group based on the advice of the Members of the Group and of the Secretary. The RASG -AFI meetings shall normally be convened annually at the location of the ICAO Regional Offices in Dakar, or Nairobi, to the extent possible, to facilitate proper access by States. Approval to host RASG-AFI meetings outside of the Regional Office must be obtained from the President of the ICAO Council. If a State offers to host the meeting, it shall coordinate with the Secretary of the Group as early as possible, but in any case, at least six (06) months in advance.
- In this regard, the Secretariat presents the proposal for 2025 activities of the RASC, the Safety Support Teams (SSTs), the Annual Safety Report Team (ASRT), and RASG-AFI meetings.

- 3.1. The meeting is invited to:
  - a) Review and endorse the proposed activities of the RASG-AFI and its Contributory Bodies for 2025 as contained in the **Appendix** to this paper; and
