- 1. I would like to inform you that the 2020 Meeting of the Directors General of Civil Aviation of the ICAO European and North Atlantic Regions (EUR/NAT-DGCA/2020) will be convened in the European and North Atlantic Office of ICAO in Paris from 20 to 21 October 2020, starting at 09:30 with registration from 09:00 onwards.
- 2. This year the Meeting will focus on a few topics of high interest in the EUR/NAT Regions for the Directors General's level. Our initial view is to include the following items on the agenda:
 - a) sustainable financing of civil aviation authorities (civil aviation and accident investigation authorities);
 - b) contingency planning and emergency response (i.e. ATM contingencies, volcanic ash and nuclear contingencies, prevention and management of public health events (CAPSCA)), including the status of preparedness 10 years after the eruption of the Eyjafjallajökul Volcano;
 - c) RPAS/drones operations across EUR/NAT Regions.
