Updates will be provided on ICAO's activities aimed at achieving the long-term global aspirational goal (LTAG) for international aviation. States and Organizations will be invited in particular to take action in the framework of the ICAO Assistance, Capacity-building and Training for Sustainable Aviation Fuels (ACT-SAF) programme.

Agenda Item 6: Enhancing resilience

Updates will be provided on ICAO's activities related to crisis preparedness and management. States and Organizations will be invited in particular to take action to support the effective operation of Air Transport Facilitation Committees, their use of guidance and assistance provided by the Collaborative Arrangement for the Prevention and Management of Public Health Events in Civil Aviation (CAPSCA), as well as to enhance collaboration on cybersecurity-related issues.

Agenda Item 7: Collaboration for implementation support: enhancing coordination and cooperation

Updates will be provided on ICAO's implementation support activities. Regarding aviation safety specifically, and to help enhance effectiveness, convergence and efficiency in implementation support activities in safety-related areas, States and Organizations will be invited to consider providing support for the development and implementation of a State-specific "Collaborative Implementation Support Roadmap" for selected States in the EUR/NAT area.

Agenda Item 8: Gender Equality

Updates will be provided on ICAO's activities related to promoting greater gender equality in civil aviation. States and Organizations will be invited to consider providing financial and in kind support to the ICAO Gender Equality Programme and implementation of the Assembly Resolution A41-26, including sponsoring young women from developing States in the EUR/NAT area to pursue aviation disciplines.

Agenda Item 9: Ratification of international air law treaties

After being provided with information on the main provisions and benefits of six key international air law treaties, the ratification process, as well as on the resources available for States to assist them with ratification matters, States will be invited to submit "tracking matrices" in order to track the status of ratification of those key treaties.

Agenda Item 10: Any Other Business and Next Meeting

States and Organizations will have the opportunity to address other matters not covered in the agenda and make proposals regarding the date and location of the 2024 EUR/NAT-DGCA Meeting.
