

COLLABORATIVE ARRANGEMENT FOR THE PREVENTION AND MANAGEMENT OF PUBLIC HEALTH EVENTS IN CIVIL AVIATION (CAPSCA)

Seventh meeting

CAPSCA-EUR/07

Helsinki, Finland, 10-12 April 2019

Summary of discussions

1. Summary of discussions

- 1.1 The ICAO European and North Atlantic Office in coordination with ICAO Headquarters ANB/Aviation Medicine Section organized the Seventh European Meeting of the Collaborative Arrangement for the Prevention and Management of Public Health Events in Civil Aviation (CAPSCA-EUR/07) as well as presented to the meeting participants the developments in the ICAO Headquarters (CAPSCA global programme) and the European Region (CAPSCA EUR) in this respect.
- 1.2 Among the objectives of the meeting were:
 - to develop a clear understanding of the importance concerning the preparedness in the aviation sector of all stakeholders involved, for a public health event
 - to underline the need for early and coordinated involvement of all stakeholders during a public health emergency
 - to share experiences, best practices and lessons learned regarding Disinsection/Disinfection guidelines and practices.
 - to share experiences, best practices and lessons learned from the Public Health exercises conducted recently within the EUR/NAT region.
- 1.3 Thanks to the kind invitation of Finland, Traficom, Civil Aviation Authority, the meeting was held in the premises of the Scandic Hotel, Helsinki, from 10 to 12 April 2019, with 86 registered participants from 24 States, 10 International Organisations
- The meeting recalled that the first CAPSCA regional project commenced in the Asia Pacific region in 2006 in order to assist States to implement public health-related amendments to the ICAO Annexes, which in turn are based on the WHO International Health Regulations (2005). There are now CAPSCA regional projects in all regions (Europe, Asia Pacific, Africa, the Americas and the Middle East). The project is managed globally by ICAO HQ, in consultation with the World Health Organization, and a number of other UN specialised agencies and industry partners (e.g. Airports Council International, International Air Transport Association etc.). - 1.5 The meeting participants discussed the ICAO CAPSCA programme and activities at both Global and Regional levels, including the CAPSCA mandate, aims and objectives, key achievements, multisector collaboration within States and between States and international organisations, CAPSCA assistance visits etc. (see attached programme of the meeting). It was noted again by the meeting participants that the overall objective of the project is to protect public health general public, air travellers, and aviation personnel, to harmonize regulations and working practices so as to comply with the ICAO SARPs and WHO International Health Regulations (2005), and to minimise disruption and consequent adverse economic effects to the aviation sector and enterprises that rely on it, during Public Health Emergencies.
- 1.6 The CAPSCA Programme was fully supported by the meeting as it promotes cooperation and coordination between the Aviation sector and Public Health sector within States, international organisations and industry. It was particularly underlined by the meeting, the capacity of the CAPSCA network depends of the strength of the ties between its members and partners.
- 1.7 Concerning the development of the ITP for the Training of CAPSCA Technical advisors, the meeting noted the joint presentation of ICAO and JAA TO on this topic. According to ICAO GAT requirements a final evaluation of the ITP by a group of CAPSCA experts is actually on going and following the contractual agreement between the ICAO RTCE involved (JAA TO) and ICAO GAT. It was also noted,

that although the ITP was developed by CAPSCA EUR it will be available for global use (CAPSCA-EUR/07-C2, refers).

- 1.8 Clarifications were also provided about the request for in kind and financial contributions; they are managed by ICAO HQ through the dedicated voluntary CAPSCA fund and the SAFE fund (CAPSCA-EUR/07-C3 refers). Furthermore, CAPSCA EUR will continue to facilitate sharing of best practices and lessons learned, through annual meetings including OJT activities and the support/participation in similar activities (e.g. table top and full scale exercises, webinars, meetings) form States and other relevant organizations in the region (e.g. WHO, EU, ECDC, NM/EACCC- CAPSCA-EUR/07 C4 & C8 refer).
- 1.9 The meeting encouraged CAPSCA Global Programme to continue the collaboration with WHO and IATA, for the development of disinsection/disinfection guidelines and the review of the passenger information for contact tracing purposes (CAPSCA-EUR/07 C5 & C6 refer).
- 1.10 The CAPSCA EUR/07 meeting agreed the following conclusions:

CAPSCA- EUR/07-C1:

States are encouraged to:

- Join CAPSCA by sending a letter or a simple email to the ICAO EUR/NAT Regional Office (<u>icaoeurnat@paris.icao.int</u>, <u>spoulimenakos@paris.icao.int</u>, <u>mbrunette@paris.icao.int</u>). CAA and PH representatives are encouraged to participate in CAPSCA activities
- ICAO EUR/NAT to send a State Letter to States which are not yet CAPSCA members, encouraging them to join.

CAPSCA- EUR/07-C2:

The meeting acknowledged the development of an ICAO Training Package (ITP) by the ICAO EUR/NAT-WHO Europe, WHO PAGNET, JAA TO to establish and support a standardized and sustainable training/learning system for the CAPSCA Technical Advisors (CAPSCA-EUR04-C7 and CAPSCA-EUR05-C6 refer). States are encouraged to nominate representatives to enrol for the training when it is available.

CAPSCA- EUR/07-C3:

States and International Organizations are encouraged to:

- Enhance cooperation and coordination between the relevant international organizations and intergovernmental bodies within the European region to avoid duplication of work and optimize the use of limited resources at both strategic and operational level, including Training and Capacity building activities
- Provide in kind and/or financial support for CAPSCA activities.

CAPSCA-EUR/07 - C4:

States are encouraged to share best practices and lessons learned from public health emergencies through expert exchanges e.g. on communication issues, developing/testing SOPs/ emergency procedures, disinfection/disinsection practices. ICAO EUR NAT Office will continue to facilitate these activities organizationally and to further organize regional meetings and trainings, as needed.

CAPSCA-EUR/07 - C5:

WHO and ICAO are encouraged to continue with collaboration on the review, development and publishing of guidelines and training material for disinsection in aviation. States are encouraged to participate in these activities and share information.

CAPSCA-EUR/07 - C6

ICAO to collaborate with relevant stakeholders in investigating current practices and revising and developing guidelines in relation to obtaining passenger information for contact tracing purposes, having best-practice standards, information sharing and awareness.

CAPSCA-EUR/07 - C7:

CAPSCA recommends that States raise awareness among their stakeholders in regard to the necessary preventive measures concerning communicable diseases (i.e. vaccination, etc.) for their staff involved in civil aviation operations.

CAPSCA-EUR/07 – C8:

The meeting recommends that States organise PHE exercises involving all stakeholders.

CAPSCA-EUR/07 – C9:

The meeting thanked Switzerland, Hans Ulrich Aebersold, for competently and devotedly chairing CAPSCA EUR for the last three years.
