Preliminary Programme

Session 1: Introduction to ICAO's work on environment : to provide States with an overview of ICAO's environment-related activities.

Session 2: Introduction to CORSIA: An overview of the Carbon Offsetting and Reduction Scheme for International Aviation (CORSIA), including its goals, objectives, and implementation details.

Session 3: CORSIA Regulations and Compliance: A detailed explanation of the CORSIA regulatory framework, including the Monitoring, Reporting, and Verification (MRV) requirements for participating States.

Session 4: CORSIA Offsetting Mechanisms and eligible fuels: Discussion on the different offsetting mechanisms approved by CORSIA, such as carbon credits, sustainable aviation fuels, and renewable energy projects.

Session 5: CORSIA Implementation Challenges: Identification and discussion of the challenges that airlines and other stakeholders may face during the implementation of CORSIA, including data collection, reporting, and potential financial implications.

Session 6: CORSIA Review Process: Explanation of the periodic review process to evaluate the effectiveness and progress of CORSIA in achieving its emissions reduction goals.

This session will introduce the State Action Plan initiative and provide more details on how State Action Plans relate to ICAO's various work streams, including CORSIA and the ICAO Stocktaking process.

This session will provide more detail about the SAP development process, including a breakdown of the baseline scenario development process, descriptions of the mitigation measures, and how to develop the expected results.

Session 10: outcomes of CAAF/3 with a view to provide States with the outcomes of CAAF/3 and updates of the 2050 ICAO Vision including quantified proportion of CAF to be substituted with SAF by 2050, and carbon reductions achieved by SAF.

Session 11: ICAO Assistance, Capacity-building and Trainning on CORSIA (**ACT-CORSIA**)

Each session will be followed by Group Discussions: Opportunities for participants to ask questions, engage in group discussions, and share their experiences and perspectives.
