I have the honour to invite your Administration/Organization to participate in the Middle East Regional Seminar on Advance Passenger Information (API) and Passenger Name Record (PNR) Data to be held in Cairo, Egypt, from 23 to 25 June 2024.

Annex 9 – Facilitation to the Chicago Convention obliges that all Contracting States shall establish Advance Passenger Information (API) systems and develop the capability to collect, use, process and protect Passenger Name Record (PNR) data. Moreover, Annex 9 obliges States requiring API and/or PNR data from aircraft operators to create a Passenger Data Single Window facility for each data category, or both data categories combined.

The transfer of API and PNR data by aircraft operators to States allows public authorities to check watchlists, conduct analysis and take operational decisions. The availability of such pre-travel and pre-arrival passenger data allows the application of appropriate risk management techniques by States to expedite clearance processes at border control points and focus resources on travellers assessed to pose higher risk.

I encourage you to distribute this letter to all appropriate entities in your State, such as immigration, customs, counter-narcotics, counter-terrorism, travel document and visa issuing entities, INTERPOL National Central Bureau (NCB), other interested law enforcement agencies, as well as aviation security authorities. aircraft operators, airport authorities and other interested stakeholders.
