#### **1. INTRODUCTION**

1.1 The Twenty First Meeting of the Middle East Air Navigation Planning and Implementation Regional Group and the Eleventh Meeting of the Regional Aviation Safety Group-Middle East (MIDANPIRG/21 & RASG-MID/11) were held in Abu Dhabi, UAE, 4 - 8 March 2024. The MIDANPIRG/21 meeting adopted 33 Conclusions and Decisions of which two (2) conclusions were relevant to the work of the ATFM Task force.

#### 2. DISCUSSION
