This webinar is addressed to the ICAO NAM/CAR Regions (North America, and the Caribbean) States, Territories and International Organizations.

This webinar will build off of the first webinar and will answer questions posed, as well as requests for additional information on some points previously raised.

Currently, the traffic outlook and forecast do not present a clear picture, however, the current level of operations and proposed dates for travel restrictions to be lifted in the region point toward a slow recovery.

In this context, the competencies, wellbeing, and adequate supervision of ATC personnel will play a key role.

This webinar will provide information for compliance with the ICAO Council Aviation Recovery Taskforce (CART) recommendation to support the fastest possible return to normal aviation operations by regularly reviewing the necessity of continuing the application of risk mitigation measures, as the risk of COVID-19 transmission diminishes; as well as measures which are no longer needed and should be discontinued.


The webinar will also provide additional information to apply the NACC Regional Office Strategic approach recommendations with regards to Air Traffic Management.
