#### NACC Systemic Assistance Programme (SAP)

- ✓ Initiated on February 2015 in response to the ICAO "NO COUNTRY LEFT BEHIND" Campaign;
- Establish a Political Commitment with the States and Territories with an increase in the safety and security oversight of their civil aviation systems;
- Assists States in implementing ICAO Standards and Recommended Practices (SARPs);
- Also promotes ICAO's efforts to resolve Significant Concerns (SSCs and SSeCs);
- ✓ **Sustainability and regional collaboration**; and
- **Systematic** approach to assistance to the State.



The political Commitment will be manifested through **COSPA** between ICAO and the State


