**Towards Effective Implementation Support**

Presented by the Secretariat

ICAO Council (C-DEC 229/1) took an innovative stance in agreeing to Priority Focus Areas (PFAs) that would steer the organizational efforts during the current triennium.

PFAs do not supersede the current Strategic Objectives, but rather support them and are already covered in the 2023-2025 Business Plan. Both the PFAs and the strategic plan should bolster the ICAO Global Plans following a more structured approach of clear programmes addressing the goals of the Organization.

ICAO **FPA Implementation Support** establishes ICAO Organization-wide processes to better guide its implementation support, capacity development assistance, and resource mobilization efforts aligned with the Policy on ICAO implementation support provided to States.

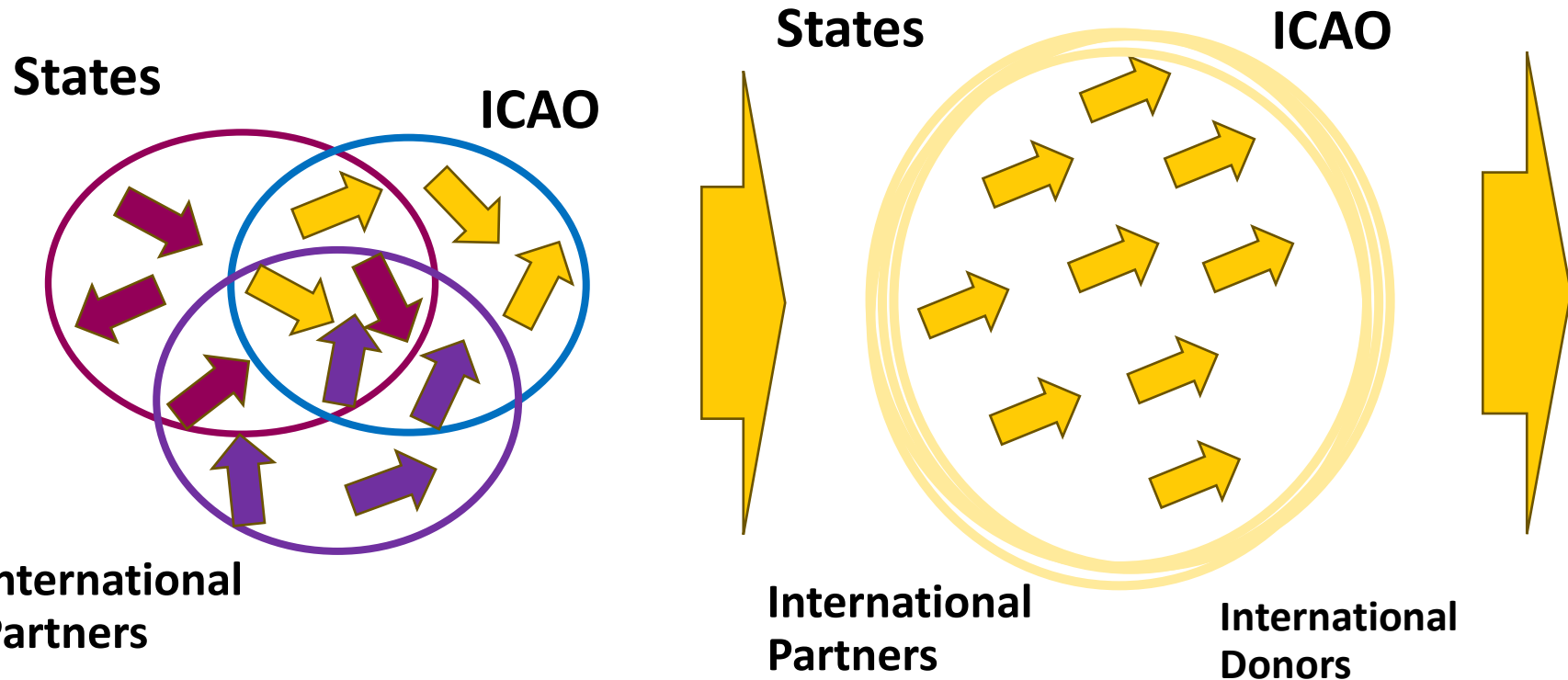

# ICAO Safety Assistance activities, initiatives and projects

1. Virtual assistance to the States, as part of the follow-up to the ICAO USOAP validations and NACC projects
2. NCMC Meetings and NCMC Working Groups
  - Establishment of two working groups (for English and Spanish speaking States), under the supervision and monitoring of the NACC Regional Office.
  - Conduct all On-Line Framework (OLF) functions in a three-year cycle to support the sustainability and the continuous improvement of regulations, guidance material, surveillance and certification responsibilities
  - Improve existing tools such as "**Methodology for Calculating the Number of Personnel Needed in the CAAs**" and on the development of a "**Model Training Program Document**" and a "**customized OLF workshop**" to be imparted virtually by the second semester of 2024.



## 3. Safety Oversight Improvement Project

### OBJECTIVES:

- ❑ Ensure that NACC States have the tools to develop the capacity to maintain an adequate level of Safety Oversight (sustainability).
- ❑ Support the establishment of a comprehensive Safety Oversight System (SOS) that guarantees the worldwide confidence and validation of the NACC States SOS, regardless of the entity or the review methodology used.
- ❑ Develop a Cross-reference Document Evaluation Tool (CRDET) of the different checklists for USOAP, IASA, and EASA audits

The experts received training in:

- IASA philosophy of audit (virtual)
- IATA IOSA familiarization (IATA MIA)
- SAFA training (ASCA Dominican Republic)





## 4. Deployment of Virtual and on-site workshops

- The ICAO NACC Office has deployed several virtual workshops related to OLF and the scope of the USOAP CMA protocol questions for Mexico and other States and coordinated onsite OLF workshop provided by HQ in the last NCMCs meetings.
- As part of the NCMC WG task for the second semester of 2024 is planned to deploy an improved virtual OLF workshop to reach as much civil aviation inspectors as possible.

## 5. SSP Implementation Project

### Project objectives

- Improve the capacity of the States, provide the tools to enhance the SSP document and its implementation in the States of the CAR Region.
- Foster among the States the provision of courses required for the development/implementation of the SSP.



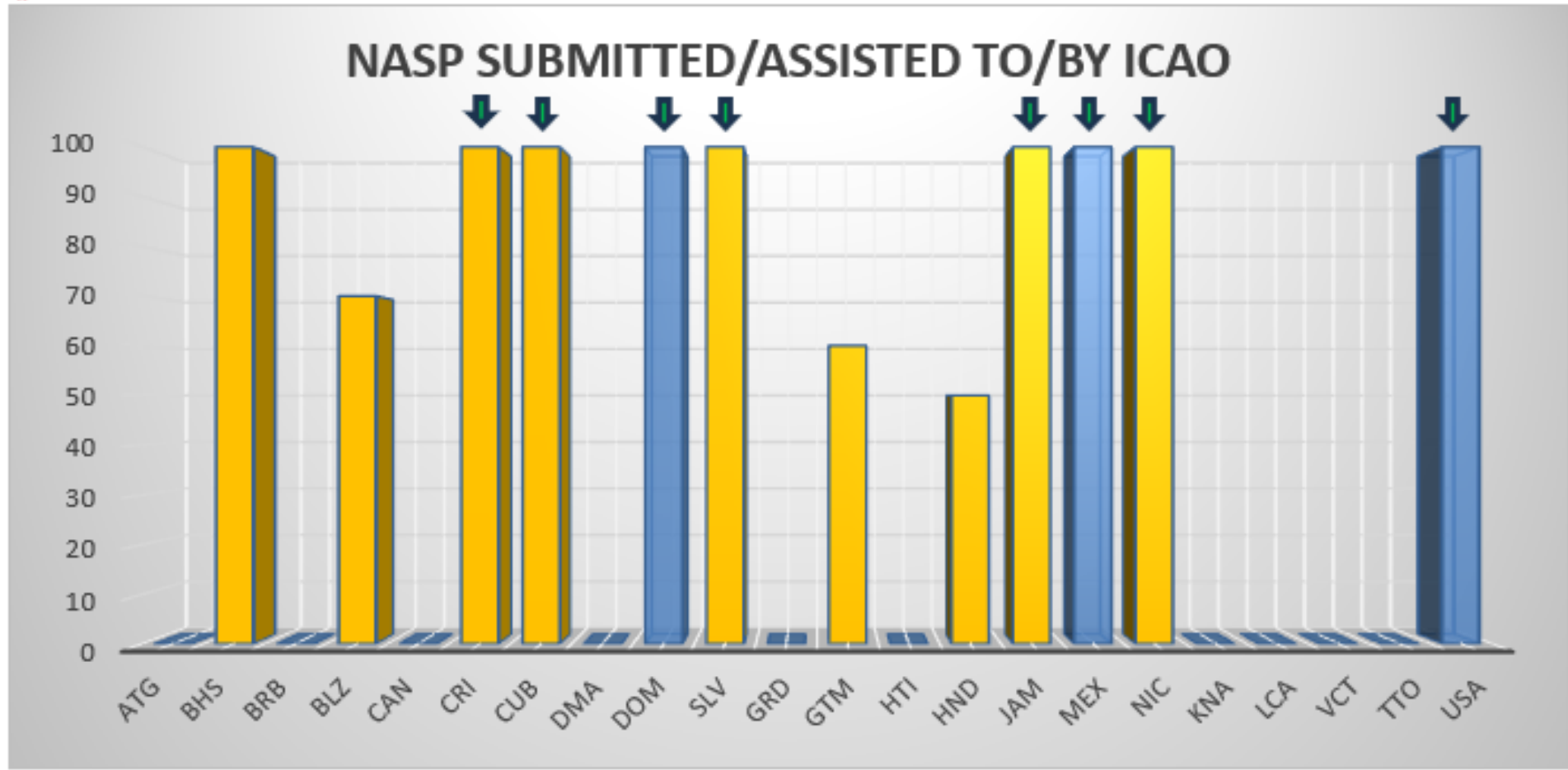
## 6. NATIONAL AVIATION SAFETY PLAN (NASP) IMPLEMENTATION PROJECT

**OBJECTIVE:** to ensure, by the provision of the appropriate training and guidance, that CAR States have the required tools and knowledge to develop their NASPs and have the NASP approved.

- ❖ NASP virtual training provided
- ❖ NASP implementation workshop - aimed at assisting the States with a technical review of the NASP preparation guide and the necessary methodologies for its development
- ❖ on-site technical assistance missions, carried out by SMEs, and the ICAO Safety Implementation Regional Officer.
- ❖ Ongoing- the action plans by the evaluated States.

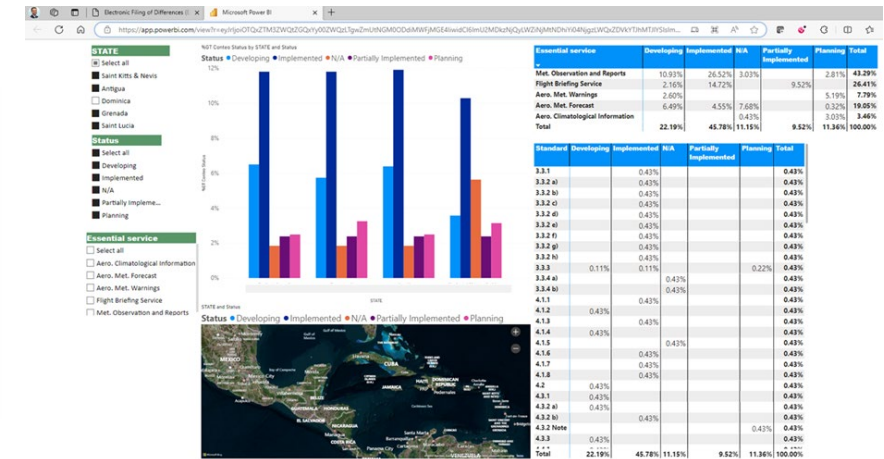

Coordination with **GREPECAS NEOSpace Project** has been agreed to work a fully regional CAR/SAM Air space optimization deployment.



During the **NACC/WG/08 Meeting**, it was explained the framework of the **AIM Basic Building Blocks (AIM - BBBs)**, with the fundamentals for air navigation, which define the essential services provided to international civil aviation. It was also explained the D-AIM from the Aviation System Block Upgrade (ASBU).

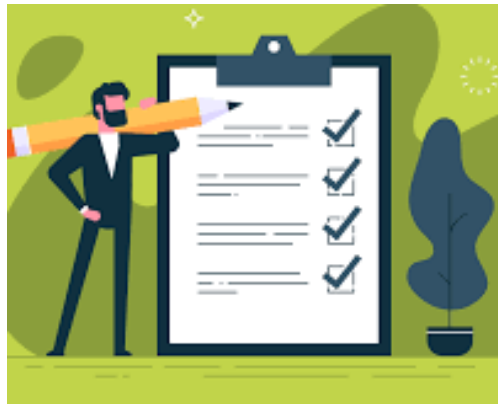

Promote the continuation of the SAR agreement for the Eastern Caribbean.



Encourage Eastern Caribbean States to declare and update their current SAR capabilities and assets.

Request Piarco RCC and related RSC to coordinate and rehearse their SAR operational procedures.

- With this theme, the **purpose of the conference** is to reach a global consensus on which **performance improvement** initiatives can best help ICAO, Member States and industry address, with limited resources, global environmental challenges and rapidly evolving aviation operations and technologies.

The **CLAC-LACAC** offered their **Platform** for continuing the sharing of papers and supports to these papers for LACAC/ CLAC members and non-members.

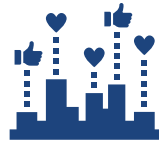


# GISS 2024 - Recap
