


What is the SAAQ?

- In 2005, ICAO introduced the SAAQ to collect information related to States' aviation activities in preparation for a USOAP audit during CSA to CMA transition.
- Today, it collects comprehensive and specific information on States' aviation activities to assist ICAO with continuous monitoring of the State's level of activity in each related audit area.
- ICAO also uses the SAAQ to support the prioritization and planning of USOAP CMA activities.

USOAP CMA MOU

MOU Article 3,

Information to be submitted and updated regularly by the State through the USOAP CMA online framework (OLF) will include the following:

- responses to the State Aviation Activity Questionnaire (SAAQ),
- Self- assessment, status of the USOAP protocol questions (PQs),
- responses to ICAO Mandatory Information Requests (MIRs),
- information relating to Significant Safety Concerns (SSCs),
- updates to the State Corrective Action Plan (CAP),
- including information regarding implementation status, and
- as far as practicable, any other relevant safety information, as requested by ICAO.



State Responsibility - SAAQ

- A State's information should be reviewed and/or updated on the OLF <u>at least once</u> every 12 months.
- States can also download a pdf version of the SAAQ from the CMA Library on the OLF or request a Word version from ICAO to complete offline and, later, enter on the OLF.

• States can export the SAAQ file from the CMA library on the OLF to complete offline. The exported file should not be merged or modified. And later, the State can import the completed document (file) on the OLF.

- The State Dashboard shows the completion percentage for each Part of the SAAQ and the date the Part was last updated.
- The State Dashboard also shows the number of questions with responses over the total number of SAAQ questions for each Part.



Helpful Tips for the SAAQ

- Provide accurate SAAQ responses based on the current state of the State's safety oversight system
- Reference public URLs, if necessary
- Coordinate with all necessary organizations to ensure accurate responses, if necessary
- Consider referencing previous SAAQ responses to minimize the overall workload
