EXECUTIVE SUMMARY

The Ninth Meeting of the African Flight Procedure Programme (AFPP) was held from 23 to 25 October 2023 in Lomé, Republic of Togo. The meeting was attended by fifty-six (56) participants from 23 member States and Organizations, including the participation of the Directors general of the civil aviation authorities of Gabon, Senegal and Togo and the Director of Air Navigation Services of Uganda.

The meeting discussed the issues raised either by the Secretariat or the participating members and took thirteen decisions.

The objective of this working paper is to review and adopt the report of this meeting.

1. INTRODUCTION

- 1.1 The Ninth Meeting of the African Flight Procedure Programme (AFPP) was held from 23 to 25 October 2023 in Lomé, Republic of Togo. The meeting was attended by 56 participants from 23 member States and Organizations, including the participation of the Directors general of the civil aviation authorities of Gabon, Senegal and Togo and the Director of the Air Navigation Services of Uganda.
- 1.2 The opening ceremony of the meeting was led by the Togolese Minister of Roads, Air and Rail Transport, Mr. Affoh ATCHA-DEDJI. The meeting was chaired by the Director General of the Civil Aviation Authority of Togo as vice-chair of the Steering Committee.
- 1.3 The meeting adopted the agenda item and the work programme and following the discussions on the agenda items, took twelve decisions.

- 2.3 As of 19 November 2024, no input was received. However, ICAO was officially informed by Namibia that they can no more host the Tenth Meeting of the Steering Committee at the planned date because of the presidential elections taking place at the same period.
