

African Flight Procedure Programme (AFPP)

REPORT ON THE 9th MEETING OF THE AFPP STEERING COMMITTEE

23 - 25 October 2023, Lome, Togo

1. VENUE, DATE AND ATTENDANCE

- 1.1 The 9th meeting of the African Flight Procedure Programme (AFPP) Steering Committee was held from 23 to 25 October 2023 at the "Hotel du 2 février" in Lome, Togo.
- 1.2 The meeting was attended by 55 participants from 23 Member States and Organizations, the host Administration, Donors, the ICAO Regional Offices and international and regional organizations. The list of participants is provided in Appendix 1.
- 1.3 The meeting was attended in-person by the Director General of the Civil Aviation Authority of Senegal (ANACIM), Mr. Sidi Gueye, the Director General of the Civil Aviation Authority of Gabon (ANAC Gabon), Mr. Eric Tristan Franck Moussavou and the Director General of the Civil Aviation Authority of Togo (ANAC Togo), Mr. Latta Dokisime Gnama.
- 1.4 In the absence of the Chairperson of the Steering Committee, Mr. Hamza S. Johary, the meeting was chaired by the Vice-Chairperson, Mr. Latta Dokissime Gnama.
- 1.5 The working languages were English and French with simultaneous interpretation. The meeting documentation was made available on the meeting website (https://www.icao.int/WACAF/African-FPP/Pages/AFPP-SC9.aspx).

2. **OPENING OF THE MEETING**

- 2.1 In the opening session, a minute of silence was observed in memory of Elhadji Ayaha Ahmed and Mr. Nassur Ben Ali, respectively Director general of the Civil Aviation Authority of Niger (ANAC Niger) and Director General of the Civil Aviation and Meteorology Authority of Comoros (ANACM) who had passed away during the year.
- 2.2 During the opening ceremony on 23 October 2023, remarks were delivered by the Vice-Chairperson, , Mr. Latta Dokissime Gnama, the representative of the Director General of ASECNA, Mr. Komla Amewokpo Sumsa, the Regional Director of the ICAO Western and Central African (WACAF) Office, Mr. Prosper Zo'o Minto'o, and the Minister of Roads, Air and Rail Transport of the Togolese Republic, Mr. Affoh Atcha-Dedji.
- 2.3 The Vice-Chairperson, Mr. Latta Dokissime Gnama welcomed the participants and commended the presence of the Minister of Roads, Air and Rail Transport at this important meeting. He outlined the importance of the Programme and its positive impact on the safety of aircraft operations in the Region.

- 2.5 Mr. Prosper Zo'o Minto'o welcomed the delegates and conveyed the greetings of the President of the ICAO Council and the Secretary General of ICAO. He extended his sincere appreciations to the Government of Togo for hosting the meeting and for the excellent facilities provided. He expressed his thanks to the Minister for attending this opening ceremony and recalled the objective of the meeting, which was to review the activities conducted in 2022-2023, approve the 2024 activities and the corresponding budget. He finally thanked the participants from States, international and regional organizations as well as industry present at the meeting.
- 2.6 The meeting was officially opened by the Minister of Roads, Air and Rail Transport, Mr. Affoh Atcha-Dedji. The Minister welcomed the participants on behalf of the government of Togo and on his own behalf. He recalled the background of the Programme and the assigned objectives and highlighted the satisfactory PBN overall implementation status in Africa. Recognizing the importance of the Programme for the safety and the efficiency of flight operations, he called the participating members for more support.
- 2.7 He further recalled the change in the AFPP governance documents approved during the last Steering Committee meeting and invited the participating members to sign the Management Service Agreement (MSA) as soon as possible.
- 2.8 He expressed his gratitude to the President of the Togolese Republic, His Excellency Mr. Faure Essozimna Gnassingbé. He concluded his address by wishing the participants a pleasant stay in Lomé and fruitful deliberations.

3. **REVIEW OF THE AGENDA ITEMS**

3.1 Adoption of the agenda and the work programme

3.1.1 Verification of the quorum

3.1.1.1 The meeting was attended by 22 Participating Members with voting rights out of the 37 (18 Active Members and four other members with voting rights). With this participation rate of 59.5 per cent, the meeting was declared valid since the minimum quorum is 33 per cent of the participating members with voting rights, as stipulated in the project document (Section 5 - Institutional Framework, §5.1- Conduct of the Steering Committee meeting).

3.1.2 Adoption of the agenda and work programme

3.1.2.1 The Steering Committee reviewed, and adopted the agenda and work programme as respectively per Appendices 2 and 3.

3.2 **Review of the SC/8 deliberations**

3.2.1 Review of the status of the decisions of SC/8

- 3.2.1.1 The Secretariat presented the implementation status of the 10 decisions taken during the last Steering Committee meeting (SC/8).
- 3.2.1.2 The meeting noted that eight decisions were fully implemented while three were still pending, establishing an implementation rate of 80 per cent.
- 3.2.1.3 The two pending decisions are related to the organization of a PANS-OPS oversight workshop to reverse the trend towards an increasing number of safety significant concerns (SSCs) and the signature of the Management Service Agreement (MSA) by the participating members. The meeting requested the postponement of the PANS-OPS oversight workshop due to the 2023 last semester workload. The meeting invited members who are yet to sign the MSA to expedite the signature.
- 3.2.1.4 Refer to Appendix 4 for more details.
- 3.2.1.5 The meeting also reviewed and approved the report of SC/8 meeting through the following decision.
- **SC/9-Dec01:** The report of the SC/8 meeting is approved.

3.2.2 **Review of the 2022-2023 work programme implementation status**

3.2.2.1 The meeting was presented the implementation status of the 2022-2023 work programme and noted difficulties faced by the Programme, mainly due to insufficient PANS-OPS instructors and qualified senior flight procedure designers. The meeting encouraged participating members to release such personnel. However, since there is a substantial shortage of qualified individuals for these positions, AFPP was requested to organize a PANS-OPS flight procedure instructor training course for new instructors and thus alleviate the workload of the current ones.

3.3 **Review of the implementation status of the programme**

3.3.1 **Project personnel**

3.3.1.1 The Secretariat presented the status of the activities related to the project staff positions as per the table below:

	As of 15 October 2023, 8 applications were received, two from candidates from other African countries who already live at the duty station, one from an ECOWAS citizen and two from non-African countries (Lebanon, Canada) with sufficient language skills, and three from other African and non-African candidates with insufficient language skills. The applications are being reviewed.

3.3.1.2 The meeting took note of the presented status.

3.3.2 Status of the AFPP Membership

- 3.3.2.1 The Secretariat recalled the membership, the corresponding voting rights and obligations and presented the status of the AFPP membership. As of 23 October 2023, in line with decisions SC/7-Dec14 and SC/8-Dec03, eight members with more than 3 years arrears as of 31 December 2022 lost their status of Active Members. Five other Active Members will also lose their status if their arrears are not cleared at least partially, so as to stay below the threshold of three years, by the end of 2023.
- 3.3.2.2 The meeting recalled that the status of active member can be recovered by reducing the arrears in annual membership fees below the threshold of three years and encouraged members to include the annual contributions in their budget. The meeting also recalled that the Programme users cannot benefit from the privileges granted to the active members such as free participation to the trainings and workshops organized by the Programme and discounted rate for the direct assistances.

- 3.3.2.3 The meeting noted that no new application to join the Programme was received by the project since SC/8. However, Zambia has expressed interest to join the AFPP with effect from 1 January 2024.
- 3.3.2.4 The meeting was also informed that the revised Management Service Agreement (MSA) was signed by the host administration. As per SC/8-Dec07, States and Organizations were requested to sign the new MSA to formally confirm their membership in the AFPP. The meeting requested AFPP to take the opportunity of the next coming 26th meeting of the Africa-Indian Ocean (AFI) Planning and Implementation Regional Group (APIRG) to get the signatures as more Directors general will attend it.
- 3.3.2.5 No decision was taken under this agenda item.

3.3.3 **Review of the approved budget**

- 3.3.3.1 The project budget which was approved during the 8th meeting of the Steering Committee was not fully implemented for the years 2022 and 2023. The differences between the budget and the actuals are mainly due to the delayed deployment of project staff and related savings in mission travel.
- 3.3.3.2 As the contributions received since SC/8 are about \$130,000 higher than the expenditures, the fund balanced increased to about \$473,000 as of 30 June 2023.
- 3.3.3.3 The Steering Committee noted the presented information.

3.3.4 **PBN implementation status in the AFI Region**

- 3.3.4.1 The Secretariat presented the implementation status of the Performance-based Navigation (PBN) in the AFI Region as of 23 October 2023.
- 3.3.4.2 The NPIP ¹implementation rate is 81 per cent (39 out of 48 ESAF and WACAF States). Regarding the PBN flight procedures, the implementation rates in the AFI Region is presented below:
 - a) 76.1 per cent for RNP APCH;
 - b) 56.3 per cent for APV baro-VNAV²;
 - c) 37.7 per cent for SIDs³;
 - d) 50.2 per cent for $STARs^4$;
 - e) 12.1 per cent for CCOs⁵; and
 - f) 12.1 per cent for $CDOs^6$.
- 3.3.4.3 The report showed a reduction in the implementation rate mainly due to the suspension of instrument flight procedures following the ICAO USOAP CMA audits and/or consistency of the information on international airports in the AFI eANP.
- 3.3.4.4 The meeting noted that despite the ICAO target date of 2016 for the full PBN implementation in the Region, some States have not yet issued the National PBN Implementation Plans (NPIP).

- 3.3.4.5 The meeting pointed out WGS-84 periodic surveys, Navaid periodic calibrations, PBN flight procedures' flight evaluation and instrument flight procedure periodic maintenance as the root causes of these shortcomings and encouraged States and ANSPs to plan, budget and ensure appropriate maintenance (including revision, calibration and WGS-84) of their Navaids and instrument flight procedures. This will avoid waste of resources in the implementation of corrective action plans related to the USOAP CMA Safety Significant Concerns. To address issues related to the flight procedure maintenance and approval, members were also invited to take advantage of the AFPP and build in-house capability not only for the instrument flight procedure design domain, but also for the PANS-OPS oversight.
- 3.3.4.6 The meeting noted that some of the concerned States are lacking financial resources to pay their contributions and agreed on the following:
- **SC/9-Dec02:** In line with decisions SC/7-Dec01, ICAO to consider resource mobilization to support the concerned States with PBN implementation (e.g. Burundi, Zimbabwe).

3.3.5 Flight procedure design projects implementation status

- 3.3.5.1 The Secretariat presented the implementation status of the flight procedure design projects being conducted by the Programme. Seven projects were involved, including designs for nine aerodromes in seven States. The concerned States were Cabo Verde, Eswatini, the Gambia, Liberia, Sao Tome and Principe, Niger and Cameroon. The relevant aerodromes were Sal, Praia, King Mswati III, Robertsfield, Sao Tome, Arlit, Belabo and Dompta.
- 3.3.5.2 The meeting noted that the designs were fully completed for almost all of them, except the design in Eswatini, but none of them was published. Six were pending for regulatory approval which is part of States' responsibilities; and five (Eswatini, Gambia, Sao Tome and Principe, Niger and Cameroon) were still pending for full settlement. The flight procedure design projects implementation status is provided in appendix 5.
- 3.3.5.3 The meeting raised concerns regarding the non-settlement of the projects upon their completion that can affect the normal operation of the Programme took the following decision:
- **SC/9-Dec03:** In order to reduce the impact of late or non-payment for flight procedure design projects, ICAO shall issue invoices as follows (the percentages can be adapted based on the requirements/constraints of the individual States or organizations):
 - a) 70 per cent of the total amount as advance payment prior to the start of the activities;
 - b) 20 per cent upon completion of the safety studies; and
 - c) 10 per cent at the delivery of the technical report.

3.3.6 **Review of the project members' commitments**

- 3.3.6.1 The Secretariat recalled the Project Membership and presented their respective commitments as evidenced respectively in the Programme Document, the Management Service Agreement and the Lette of intent.
- 3.3.6.2 As per the Letter of intent and the Programme document, ASECNA committed to release a PANS-OPS expert and provide inter alia premises suitably equipped with IT equipment and software, charting software, internet, telephone with access international calls and a car.

- 3.3.6.3 The meeting noted that if most of the commitments were implemented, some were still pending: the charting software, the vehicle and the drawing tables are still awaited, and the building is facing maintenance issues. Since more than one year there is no more telephone, Wi-Fi and internet. The Representative of the Director General of ASECNA noted the information and informed the meeting that actions were taken to address them.
- 3.3.6.4 Regarding the relationships between the Programme and individual members, the Secretariat recalled that during the sixth meeting of the AFPP Steering Committee held virtually on 3 September 2020, Kenya Civil Aviation Authority offered to donate one license of an aeronautical charting software to the Programme and requested TCB to submit to KCAA a po-forma invoice (SC/6-Dec06). However, the discussions with the software provider are still pending.
- 3.3.6.5 Kenya maintained its intention to provide funding for the procurement of aeronautical charting software upon submission of the corresponding invoice by ICAO.

3.3.7 **PANS-OPS challenges in the AFI region**

- 3.3.7.1 The Secretariat presented the challenges faced in the PANS-OPS domain in the AFI region by both regulators and ANSPs. These challenges include:
 - d) Insufficient trainings;
 - e) Lack of effective regulation;
 - f) Lack of oversight;
 - g) High staff turnover due to insufficient compensation of technical staff; and
 - h) Lack of automated charting software.
- 3.3.7.2 The meeting therefore formulated the following decisions:
- **SC/9-Dec04:** ICAO shall create and maintain a pool of qualified senior PANS-OPS inspectors who can be seconded to the AFPP by their administrations upon request, in order to assist other States with related safety oversight activities. States and organizations are invited to submit to ICAO nominations of qualified staff to be included in the pool of PANS-OPS inspectors.
- **SC/9-Dec05:** ICAO is authorized to procure PANS-OPS charting software with project funds.

3.4 **Presentation of working papers and information papers by stakeholders**

- 3.4.1 Under this agenda item, only one working paper was presented on the PANS-OPS instructors training course by Kenya.
- 3.4.2 Kenya Civil Aviation Authority (KCAA) recalled the efforts made by the Programme in the field of the capacity building and noted that since its inception in June 2014, no PANS-OPS instructor training was organized, reason why this profile is missing. They added that the instructors' shortage has put continued strain in the AFPP with lack of sufficient alternatives to address numerous individual State and Organizations.
- 3.4.3 The meeting recognized the relevance of the presented information and took the following decision.
- **SC/9-Dec06:** In order to address the lack of qualified PANS-OPS flight procedure design training instructors, ICAO shall coordinate with training centers for the release of a psychopedagogue to co-facilitate the training with the AFPP flight procedure design instructors.

3.5 **Review of the 2024 Work Programme**

3.5.1 Review of the 2024 Work Programme

- 3.5.1.1 The Secretariat presented the planned activities for 2024. The work programme was designed in line with the assigned Programme objectives as well as to address the challenges faced by the Region and respond to the request from the participating members. The work programme includes:
 - a) Seven trainings and workshops on flight procedure design, PANS-OPS oversight, quality assurance, airspace design and NPIPs;
 - b) Confirmed additional activities for five flight procedure design projects to assist with approval, publication and validation of flight procedures; and
 - c) Three expected new flight procedure design projects.
- 3.5.1.2 The meeting took noted that States/Organizations can request additional trainings as needed during the year.
- 3.5.1.3 The meeting furthermore noted the offer of Cameroon to host a full PANS-OPS flight procedure design training course and requested AFPP to take this offer into consideration for the planning of future courses.
- 3.5.1.4 The following decision was taken:
- **SC/9-Dec07:** The 2024 Work Programme is approved as presented and amended during the meeting (see Appendix 6).

3.5.2 **Project personnel**

3.5.2.1 Based on the current status of the recruitment activities and the revised work programme, the Secretariat presented the updated schedule of activities related to project personnel as per the table below.

- 3.5.2.2 Based on the presentation, the Steering Committee took the following decisions:
- **SC/9-Dec08:** The Administrative Assistant shall be appointed with effect from 1 February 2024 until the scheduled end date of Phase III on 31 July 2025.
- **SC/9-Dec09:** The two flight procedure design consultants shall be appointed for three assignments each between SC/9 (25 October 2023) and the scheduled end date of Phase III on 31 July 2025.
- **SC/9-Dec10:** The Information Technology (IT) assistant shall be appointed with effect from 1 February 2024 until the scheduled end date of Phase III on 31 July 2025.

3.5.3 Revised 2024 budget

- 3.5.3.1 The Secretariat presented the budget for the remaining period of Phase III. The key figures are the following:
 - a) the overall budget amount for the AFPP is approximately \$2.9 million;
 - b) the amount for the period from January 2023 until the end of Phase III in 2025 is about \$1.1 million; and
 - c) additional contributions of \$340,000 are required until the end of Phase III.
- 3.5.3.2 Details were provided in the working paper.
- 3.5.3.3 The Steering Committee urged the Active Members to settle their arrears in annual membership fees.
- 3.5.3.4 The Steering Committee took the following decision.

SC/9-Dec11: The budget is approved as presented (see Appendix 7).

3.6 **Review of the decisions of the meeting**

3.6.1 The meeting reviewed and approved the draft decisions presented by the Secretariat. The draft decisions will be captured in the final report of the meeting

3.7 Venue and date for the next SC meeting (SC/10)

3.7.1 The meeting took note of the offer from Namibia to host the next Steering Committee meeting and requested ICAO to coordinate with the State on the date.

3.8 Any Other Business

3.8.1 None

4. CLOSING SESSION OF THE MEETING

- 4.1 The closing session started with a vote of thanks delivered by Mr. Richard Ruhesi, Director ANS of Uganda, on behalf of the participants. He first expressed his sincere gratitude to the host of the event, the Government and people of the Togolese Republic for the warm welcome and the kind hospitality in Lomé. He also thanked the Civil Aviation Authority (ANAC) of Togo for the excellent facilities provided for the meeting, which enabled fruitful deliberations and allowed for a pleasant stay in Lomé. He thanked the Director general of ANAC Togo, Mr. Latta, and Mr. Affoh Atcha-Dedji, Minister of Roads, Air and Rail Transport, for their leadership.
- 4.2 He further congratulated the ICAO Team, in particular the Regional Director of the WACAF Office, Mr. Prosper Zo'o Minto'o and the Regional Officer, Technical Assistance and Air Transport, Mr. Christian Bechtold who availed themselves for the meeting to share their technical expertise and guidance. He extended the thanks to the AFPP management for the dedication and professionalism which made the AFPP upright.
- 4.3 Mr. Ruhesi thanked ASECNA for the continued support to the AFPP as host administration and commended the hotel le 2 Février and the organizing committee for the meals and the entertainments enjoyed during the three days stay.
- 4.4 Mr. Zo'o Minto'o, Regional Director of ICAO WACAF Office, thanked the Togolese Republic for the hospitality and outlined the dedication of the country for all initiative geared on improving air navigation safety. He called on the AFPP beneficiaries to provide more resources to the Programme to meet the expectations of all stakeholders. He commended the participants for the quality of the discussions and the decisions taken to address the issues. He congratulated the Chairperson and the organizing committee for the time management and thanked the Directors general who participated in-person to the meeting. He also called for more involvement of Directors general in future meetings for the sake of the relevance of their decisions.
- 4.5 Mr. Zo'o Minto'o also noted with thanks the offer of some States to support approved work programme activities and commended Namibia for accepting to host the next steering committee meeting.
- 4.6 He renewed his thanks to the Togolese Republic for hosting the event, and to Mr. Latta for his leadership and his continued support. He finally wished all participants a safe journey back home.
- 4.7 The meeting was officially closed by Mr. Latta Dokisime Latta on behalf of the Minister of Roads, Air and Rail Transport. In his address, he highlighted the outcomes of the meeting and the quality of the participants' contributions. He congratulated the secretariat and the ICAO Regional Director for the good job done upstream, ASECNA and the donors for the strong support, as well as the organizing committee. He thanked all participants and wished them a safe trip back to their respective countries.




