SUMMARY

1 INTRODUCTION

- 1.1 The AFI Planning and Implementation Regional Group (APIRG) was established by the ICAO Council on 23 June 1981 and has held twenty fourth (26) ordinary meetings and two (2) extra-ordinary meetings since its inception.
- 1.2 This paper proposes elements of the draft Agenda for the Twenty-Seventh meeting of the APIRG, for discussion by the APCC.

2. DISCUSSION

- 2.1.
