1. INTRODUCTION

- 1.1 The Infrastructure and Information Management Sub-group (IIM/SG) of the Africa and Indian Ocean Planning and Implementation Regional Group held its fifth meeting (IIM/SG6) in Nairobi, Kenya, from 31 July to 3 August 2023. The meeting report can be accessed on the ICAO website.
- 1.2 The results of the meeting are documented as Conclusions and Decisions, as outlined below.
 - a) Conclusions deal with matters which, in accordance with the Groups' terms of reference, merit directly the attention of States, or on which further action is required to be initiated by the Secretary in accordance with established procedures.
 - b) Decisions relate to the internal working arrangements of the Groups and their subsidiary bodies.
- 1.3 The IIMSG/6 meeting discussed ten (10) Agenda Items and acknowledged the progress made by the Subgroup in implementing its activities. However, it also recognized the recurring challenges in executing the project implementation activities.



2. DISCUSSION

- 2.1 The meeting adopted four (4) Conclusions and four (4) Decisions. Of these, only two (2) Decisions were not included in the APIRG/26 Report. The implementation status of the two Decisions outlined in Section 1 is detailed in **Appendix A.**
