**1. INTRODUCTION**

- 1.1 The guidance provided in the Generic Terms of Reference of Planning and Implementation Regional Groups (PIRGs) call for PIRGs to ensure that the PIRG meeting reports is provided in a standardized format to the governing bodies of ICAO to identify regional and emerging challenges.
- 1.2 It is also recalled that these reports should include amongst others, a list of issues cross-referenced to actions to be taken by ICAO Headquarters and/or Regional Offices.

**2. DISCUSSIONS**

- 2.1. The IIM/SG6 Meeting, held in Nairobi in 2023, discussed amongst other, actions to further facilitate regional planning and implementation activities, the AFI Air Navigation Plan, Air Navigation Deficiencies in AIM, CNS and MET areas, the status of the implementation of APIRG Projects as well as ASBU elements, for which the States' reporting level is still low in the region.

- 2.2. The meeting deliberated on the Agenda Item 7 on the proposed recommendations/actions to be taken by ICAO HQ and concluded with no identified action requiring the attention of ICAO HQ.
- 2.3. The IIM/SG7 meeting deliberated on conclusions, decisions and actions to address issues and challenges identified in the area of capacity and efficiency. Some of these may require the attention of ICAO Headquarters and the meeting should consider them accordingly.
