- 2.1 The first meeting of the South Atlantic Steering Group (SAT SG/1) was held virtually on 4 December 2024. The meeting discussed activities of its subsidiary bodies, issues related to implementation as well as future activities which led to several recommendations in terms of conclusions, decisions and actions.
