This paper proposes establishing an SAT documentation webpage to enhance the management, accessibility, and preservation of SAT documentation.

1 INTRODUCTION

- 1.1 The SAT SG/02 should consider the merits of developing an SAT Documentation Webpage to manage and preserve SAT documentation effectively. This solution is essential to address the growing complexity of SAT operations and ensure accessibility, standardisation, and harmonisation of regional materials in alignment with ICAO standards.
- 1.2 This paper outlines the suggested measures to identify required resources and establish processes for implementing this solution, leveraging digital tools to foster collaboration among SAT stakeholders.

2. DISCUSSION

- 2.1 As the model provided by ICAO groups, such as GREPECAS and NAT, a dedicated SAT Documentation Webpage is proposed as a centralised digital platform to host publications that should be publicised to airspace users, such as SAT documents, operational bulletins and guidelines, and regulatory updates. The webpage would align with ICAO's frameworks for other groups, ensuring accessibility and consistency across stakeholders.
- 2.2 To support this initiative, it is vital to identify a sponsor who will provide financial and technical resources to establish and maintain the SAT documentation page, ensuring sustainability and long-term support. Based on the experience of other

groups, it is suggested that one of the SAT ICAO Regional Offices create and host the SAT Documentation page.

2.3 Based on the foregoing, the following is proposed:

Why	To centralise SAT documentation, enhance accessibility, and ensure compliance with ICAO standards.
What	Create an accessible and centralised digital platform to host SAT-related materials.
Who	ICAO Regional Office, SAT DMO and stakeholders.
